ELECTION OF OFFICERS

A letter was received from West Fallowfield Township deferring all planning for this proposed subdivision to Upper Oxford Township.

BENJAMIN AND SYLVIA STOLTZFUS – Tax Parcel #57-4-49 (2137 Ewing Road). All fees were paid and we are waiting for reviews.

Supervisor Scott Rugen informed the Planning Commission that all files from Ron Ragan except Grist Mill were turned over to the new engineering firm. The Jennersville Hospital (now Christiana Care, will expect to be open by July 2025. Colin stated that is not actually Christiana Care but another independent company that will manage it.
