## UPPER OXFORD TOWNSHIP MAY 13, 2024

Upper Oxford Township Board of Supervisors held their regular monthly meeting at the township building, 1185 Limestone Road, Russellville on Monday, May 13, 2024 at 7:00 PM.

The meeting was called to order by the Chairman, Scott Rugen. After the Salute to the Flag, Howard Reyburn led in prayer.

PUBLIC COMMENTS – There were no comments at this time from the public.

Supervisor Fleischmann is working on a spread sheet of properties that are being pumped. Discussion was held regarding having the Tax Collector put a notice of pumping requirement included with the tax bills next April.

HISTORIC ORDINANCE – The township received a copy of the ordinance from the Township Solicitor showing his review with changes. The Supervisors will review the changes and send a copy to the Historic Commission. Discussion was also held regarding restrictive covenants.
