## UPPER OXFORD TOWNSHIP AUGUST 12, 2024

Upper Oxford Township Board of Supervisors held their regular monthly meeting at the township building, 1185 Limestone Road, Russellville on Monday, August 12, 2024 at 7:00 P.M.

The meeting was called to order by the Chairman, Scott Rugen at 7:00 P.M. After the Salute to the Flag, Scott Rugen led in payer.

PUBLIC COMMENTS – There were no comments at this time.

MINUTES – Motion was made by Charles Fleischmann, seconded by Howard Reyburn and carried to approve the July 8, 2024 Minutes.

OXFORD HISTORICAL ASSOCIATION – Krys Sipple was present on behalf of the Oxford Historical Association seeking support from the township. The Association purchased a building on Fifth Street for approximately \$700,000.00. To date, \$200,000.00 has been raised towards this purchase price. The final payment will come due at the end of 2027. The Association has plans to eventually hire a director, be part of the America 250 – promoting tourism and will have a National Exhibit in September. Blue grass music festival is planned also. The Association is asking the Board of Supervisors for a three (3) year pledge of \$3,000.00/per year, a total of \$9,000.00.

MOLLY SCOTT – questioned the Supervisors along with a few of her neighbors on the status of fixing the water run-off problem on Old Limestone Road. Supervisor Rugen stated that the township has plans to put in a new pipe (inlet) parallel with the road to the property owned by Vincent Gasper which then would empty into a basin on his property. We need Mr. Gasper's permission to have Brandywine Septic identify where his system is located before we move forward with any work. A legal agreement between Mr. Gasper and Upper Oxford will also need to be executed. The township hopes to have this completed by the spring.

TURNERS POND RETENTION BASIN - No bids were received for this project.

ZONING CHANGE – Motion was made by Scott Rugen, seconded by Howard Reyburn and carried to authorize the Solicitor to begin working on crafting an amendment to the Zoning Ordinance for the purpose of reclassifying Tax Parcel #57-8-23.1 from R2 to C2 owned by Donnelly Enterprise. The Supervisors did not agree to change zoning across Route 1. The Secretary will email the Solicitor regarding this and Supervisor Fleischmann will contact the Solicitor regarding creating a new area zoned and called C-3.
